Conditions of carriage

Carriage and all other services based on this balloon trip voucher are subject to

- a) the liability provisions applicable to aviation of the Warsaw Treaty as amended by the Hague Protocol, the Montreal Convention and EU Regulation 1008/2008, EU regulation 2027/1997 and EU Regulation 785/2004 (as amended) with the maximum liability amounts set out in law for the commercial carriage of passengers in Austria
- b) the general provisions of the terms and conditions of carriage of the company alpineballooning – austria/tirol, Andy Nairz, Josef-Wilberger-Straße 10, A- 6020 Innsbruck,
- c) the respective applicable fares and,
- d) the conditions set out in this balloon trip voucher.

The following insurance has been taken out for balloon passengers with valid trip vouchers:

1) Passenger liability insurance based on statutory provisions up to SDR 300,000.00 in the event of the death or injury of a passenger, as well as up to SDR 1,000.00 for personal effects.

2) Passenger accident insurance in the event of death or permanent disability in accordance with the general terms and conditions for aviation accident insurance (ALUB) with every passenger seat covered for up to € 40,000.00

No liability is accepted for fragile or perishable objects. The carrying of explosive, flammable or radioactive items is not permitted. In addition, any liability is excluded.

Alpineballooning – austria/tirol, Andy Nairz, Josef-Wilberger-Straße 10, A- 6020 Innsbruck is not liable for losses due to compliance with applicable legal and aviation provisions, official requirements or instructions, or due to contributory fault of the balloon passenger, or for losses to and from the balloon trip either.

The balloon passengers themselves must comply with all official travel formalities, and be in possession of all required travel, entry and other documents.
